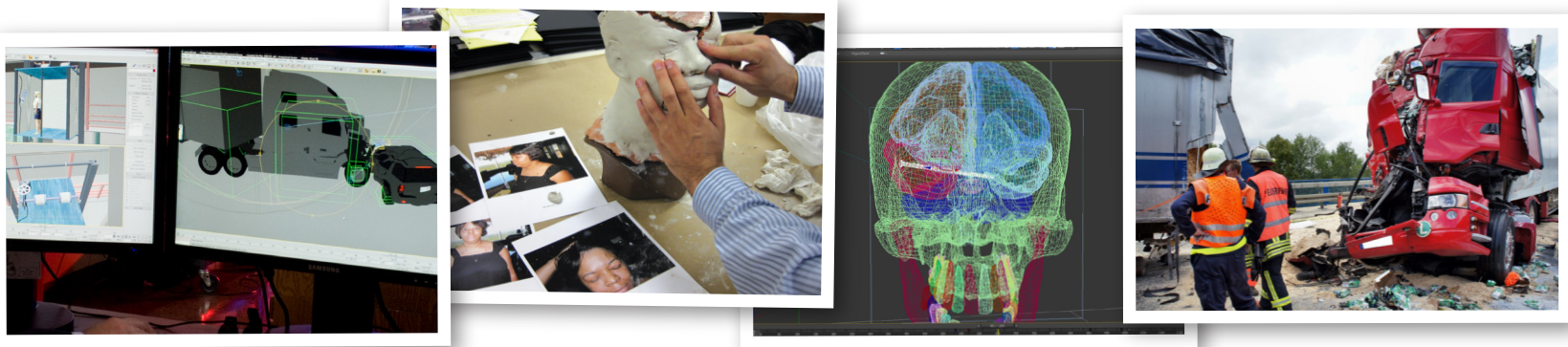

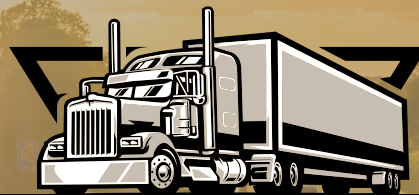

Over the next four decades, since that first million-dollar truck wreck verdict, it has been our privilege to continue to get larger verdicts and settlements for victims of 18-wheeler accidents. Because of our successes, I received the Teddy Roosevelt 'Man in the Arena' Award from the Association of Plaintiff Interstate Trucking Lawyers of America for our commitment to making roadways safer by taking on and trying 18-wheeler truck wrecks."

The list below reflects a few of our truck wreck settlements and verdicts that we are not prohibited from disclosing:

- ✦ **\$15 million settlement** with an Arizona trucking company following an 18-wheeler crash near Colorado City, Texas, that killed three family members and severely injured a fourth.
- ✦ **\$20.8 million jury verdict** for a childless 83-year-old widow, reduced to \$17 million by a trial court and resolved by confidential settlement, for the loss of her 76-year-old husband, who was killed when a tractor-trailer carrying hazardous waste caused a chain-reaction crash on a Texas highway.
- ✦ **\$7 million settlement** for a client seriously injured when her vehicle was rear-ended by a commercial truck at high speed.
- ✦ **\$7.5 million settlement** involving a death from an 18-wheeler crash.
- ✦ **\$12.95 million settlement** within six months of filing on behalf of the estate of a 76-year-old client who died from injuries when his vehicle was struck from behind by an 18-wheeler.
- ✦ **\$5.585 million verdict** for a client in an 18-wheeler crash resulting in serious injuries.
- ✦ **\$9 million settlement** for head injuries from a tractor/trailer crash.
- ✦ **\$6.675 million settlement** for the death of a 79-year-old man in a trucking crash.
